

Louis "Lou" Bernard Herbert September 10, 1945 - July 9, 2000 SCAFO's 60th President

Louis "Lou" Bernard Herbert was born September 10, 1945, in Cambridge, Massachusetts. He graduated from Ringe Technical High School in Cambridge, Massachusetts, in 1963.

Lou attended Northeastern University of Massachusetts for 2 years studying liberal arts before joining the United States Air Force in January 1965. He served as an Air Force Medical Technician and a Supervisor of Emergency Services until his retirement in January 1985.

Lou married his wife, Sandra, on March 4, 1967. They have three children, Derek, 33, Christopher, 29, and Michael, 24.

In 1985 Lou moved his family to Moreno Valley, California. Lou joined the Riverside County District Attorney's Office, Bureau of Investigation, on October 7, 1985, as an Investigative Assistant for the Subpoena Service Unit. On June 29, 1989, Lou was promoted to the position of Forensic Technician and spent the next few years building a fully functional Forensics Unit for the Riverside Office. Lou was promoted again to the position of Supervising Forensic Technician on August 12, 1999.

Lou was very involved with professional forensic and law enforcement associations throughout the State of California, including the Riverside County District Attorney Investigator's Association, The California Association for Property and Evidence (CAPE), who recognized Lou as the Property Officer of the Year for 1999, the Southern California Association of Fingerprint Officers (SCAFO), where he served as their 60th President, the High Technology Crime Investigation Association and the International Association of Identification. He was also an instructor for the American Red Cross, Riverside Chapter.

Lou was killed on the afternoon of Sunday, July 9, 2000, in a traffic accident near Kingman, Arizona, while traveling home with his wife after vacationing and attending a family reunion in Detroit, Michigan. The trailer Lou was towing was caught by a sudden gust of wind and overturned on the freeway, causing the car to overturn also.

Lou is survived by his wife of nearly 34 years, Sandra, his 3 sons, Derek, Christopher and Michael, a sister, Helen Ford of Cambridge, Massachusetts, half-sister Dorothy Robinson, half-brother Russell O'Bnnes, half-brother William Trotman, and an aunt, Edith Robertson of Boston, Massachusetts.

Lou was SCAFO's 60th President. During his year as president SCAFO had a great year. The SCAFO website was Lou's concept and was created under his direction. We celebrated our Diamond Anniversary aboard the historic Queen Mary and continued many fine traditions and friendships. Lou will be missed, but not forgotten, by his friends and colleagues in the Southern California Association of Fingerprint Officers.

SCAFO Suffers Several Losses

(With the recent passing of several colleagues and spouses of colleagues, whom we also knew as friends, the following stories from the book "The Birth That We Call Death" by Paul H. Dunn and Richard M. Eyre are reprinted.)

In a beautiful blue lagoon on a clear day, a fine sailing-ship spreads its brilliant white canvas in a fresh morning breeze and sails out to the open sea. We watch her glide away magnificently through the deep blue and gradually see her grow smaller and smaller as she nears the horizon. Finally, where the sea and sky meet, she slips silently from sight; and someone near me says, "There, she is gone!"

Gone where? Gone from sight--that is all. She is still as large in mast and hull and sail, still just as able to bear her load. And we can be sure that, just as we say, "There, she is gone!" another says, "There, she comes!"

Imagine for a moment that you are about to cross the country on a train. You get on board, and as the train starts you find yourself sitting next to a fine person who is making the same journey that you are. Since the trip usually takes almost four days, you begin a serious attempt to get to know each other. You find that you have much in common, and by the time the train steams into the darkness at the end of the first day you feel a remarkable closeness and begin to feel that the relationship you are forming may be the most important part of your journey.

After a sound night's sleep in the Pullman car, you rejoin your friend and the two of you spend another day relating to each other and experiencing the journey together. Your rapport grows still stronger, and you find yourself feeling a little sorry that the day passes so fast. By the second night your train is deep into the flat middle plains, and as you fall asleep you are thinking about the things you want to find out and talk about with your friend the next day.

In the morning you return to your seat and find, to your dismay, that your friend is gone. When you inquire, someone tells you that he got off during the night.

Got off during the night? But he had a destination very near your own, and you had planned on having the next two days with him, and there was so much more left to say! Suddenly you realize that you never did find out quite where he came from or just who he really was, and that you never did learn why he was on the train or exactly where he was going. Worst of all, you realized that you don't know whether you'll see him again --that you don't know how to find him or contact him.

The feeling is a mixture of sadness and frustration which together produce something in between bitterness and anger. Why did he have to leave? Did someone or something make him leave? Should you be upset at him for leaving or at someone else who made him go against his will? It's not so much that he's gone, it's that you don't know where he's gone and you want so much to see him again.

At that point the porter comes down the row to your seat. The message he leaves is very simple, but it changes night into day and bitterness into joy. He tells you that your friend was indeed going to the same place as you--that he was going there to see his father. During the night the train received an emergency message which instructed your friend to get off the train at the next stop and catch a plane to get home more quickly, because his father needed him right then. The porter leaves you a phone number so that you can contact your friend as soon as you arrive.

The simple message of the porter turns your frustration into peace. You are still sorry to miss the two days of discussion you had anticipated with your friend, but your sorrow is no longer bitter or blind; rather, it is sweet with the knowledge of where he is and the assurance that you will see him again.

The sorrow we taste with the loss of a loved one can be bitter or sweet, depending on one ingredient--the ingredient of knowledge; the simple, pure knowledge of our origin, our purpose, and our destination.

As in the imaginary journey on the train, the sense of temporary separation that comes to one who has this knowledge does not carry the sting and panic of permanent loss.

(Editor -- The loss of friends is always a sorrowful time, but so many in a short period makes this time of sorrow extremely difficult. As the families of each of these friends must move on with their lives, let us all remember them in our thoughts, prayers and efforts.)


Your Finger Print


